#### 5. MSA Guests – Alan Gow, Colin Hilton

Grahm Stoker was unable to attend – he'd been stewarding the F1 in Japan. Colin Hilton (Chief Executive) gave a short background for Graham Stoker (Chairman of MSC) and Alan Gow (Chairman of MSA)

Graham Stoker is a barrister. He has been a member of the MSA Judicial Committee for 20 years. He is chairman of the Judicial Committee and chairman of the Motor Sports Council. He is a Judge on the FIA's international court of appeal and a member of the FIA World Council.

Alan Gow has been in the UK for 20 years. He promotes Touring Cars. He joined the MSC 10 years ago, was appointed to the MSA Board and is now MSA chairman. Recent activities:

- Go Motosport launched, a marketing campaign to lift the profile of motorsport website
  with three sections: Go Drive, Go See, Go Help. Only clubs that have responded to the
  Go Motorsport questionnaire are listed. Some publicity is being aimed at older people
  (SAGA and similar organisations).
- Go Karting 1200 introduction sessions since July
- Rally Elite launched 3 years ago. Robert Reid working on an apprentice scheme which MSA hopes to launch in September 2009
- Today Alex Salmond announced a new event for 2009 this is an IRC event in Scotland.
- Communications a formal alliance of MSA, ACU and MIA launched two weeks ago at the House of Lords. A meeting with ministers is scheduled for November.

Dennis Turner asked about government involvement in England – CH is to see the Minister for Sport and his shadow in a week's time. He will be pressing the point that North and South Ireland, Wales and Scotland are all funding events; England isn't.

Steve Flanaghan pointed out that venues for SV rallies are disappearing. Suggestion of a motorsport co-ordinator for MoD land.

*lan Pashley* asked what were the prospects for closed public road events. CH said MSA is hopeful of progress in Wales and possibly Scotland.

Guy Robinson asked about seurity of MSA's reserves given the credit crunch – CH said the liquid investments are in gilts and low risk investments.

David James asked whether there was any progress on the government consultation on route authorisation. CH said MSA were told in October 2007 this would be complete by Christmas 2007. Government lawyers have raised questions about specified events. Thie process is still progressing.

Howard Wilcock asked about MSA communication – 3 examples in rallying in 2009: catalytic converters, fuel sampling points, new technical regulations.
