**2. Minutes of Last Meeting (14 July 2009)/Matters Arising**

The minutes were proposed a true record by Lindholme MSC, seconded by Sheffield & Hallamshire MC and agreed.

**4. Chairman's Report – Phil Foster**

*Regional Committee met in August*

- A. Regional Awards/Lifetime Honours being proposed by MSA. Executive Committee to consider. May be asking clubs for nominations.
- B. Club of the Year – one nomination passed on to MSA
- C. Marshal of the Year – no nominations
- D. Fixture List – MSA is upgrading software. Clubs must update Fixture List when applying for an on-line permit. 1450 events entered on system by beginning of August
- E. Permits – race down by 20%, overall down by 10%
- F. Licences – 3.4% down (by number)
- G. Go Motorsport: raised profile. Go Motorsport TV working model up and running. Any clubs wanting to join the pilot please contact the Chairman.
- H. Lets Go Karting – 20 venues. No visible increase in Nat B Kart licences. Kart schools not seeing any increase in numbers.
- I. Academy/Apprenticeship Scheme – started in September. ACU has joined in with the scheme. 36 people registered by mid-August.
- J. Insurance – MSA still looking at self-insuring first part of claims. Down to a shortlist of two underwriters. Bids being re-visited.
- K. Blue Book being rewritten for 2010.
- L. FIA: successor to Max Moseley – MSA had decided to back Jean Todt (before nominations closed). Graham Stoker nominated by Jean Todt as Chairman of FIA Committee.
- M. Training and Development – FIA allocated £170,000 to MSA. MSA has split this as £45,000 for Officials' training, £45,000 for facility safety programme, £80,000 for young driver safety programme. Hard-copy Club Manual has been issued to clubs. Club development fund has had 48 applications by August (paid £81,000, schemes value £630,000). 33 defibrillator units (£51,000 from fund).
- N. Rallies Committee
  - 1. Proposing equivalency factor 1:1.5 for rotary engines
  - 2. Tyres marked "Competition Use Only" are legal on road sections of events. Not legal after retiring. Chairman to seek clarification.
  - 3. Greenerways Rally: only 8 competitors. FC not yet convinced and there will be further testing of Eco tyres. Rallies Committee will be asked to develop a 5 year strategy with tyres being one item.
  - 4. WAMC Stage Championship 2010 will require mudflaps, safety film on side windows and carry environmental spill kit.
- O. Dates of championship events are part of the Sporting and Technical Regulations for the championship. They cannot be changed without every registered competitor agreeing in writing.
- P. Inter-Association Events:

1. Road Rally – WAMC 17/18 October, Lampeter & DMC, Sarn Helen. We intend to send a team. For 2010, ANICC, 20 November 2010 in the Portadown area
  2. Stage Rally. 2009 Dukeries Rally, 17 teams, 8 associations – we won!
  3. Car Trial – Ross & DMC scheduled for last weekend, but held on 28 June & won by AWMMC
  4. Sporting Car Trial – 1 November
  5. Autotest – ANCC at Rufforth on 26 July. Environmental Health observed noise levels. No problems. 2010 is 50<sup>th</sup> year of I-A Autotest
  6. Sprint – 2 August at Hames. 7 associations. 2010 event will be better in terms of communication and competitor liaison.
  7. Autocross – Green Belt/Wickford at Braintree on 26 September.
- Q. Steward and Clerks Bulletin had a note on possible conflicts of interest when Championship Co-ordinators are Clerks of the Course on qualifying rounds of their championship. The Clerks and Stewards group are to look at this again. No change in 2010 Regulations.
- R. The two Scottish Associations (ESACC & AWSMSC) merging from 1 January 2010 as the Association of Scottish Car Clubs. Will have 2 representatives on Regional Committee.
- S. MoD land – Devil's Leap and Deer's Leap on Epynt now closed to rally traffic. MoD came very close to stopping all events on their land.
